2. Request for Full time National Guard Duty for Operational Support (FTNGD-OS) tour for one DEARNG Soldier (Min: E-4 Max: E-5) in the MOS of 15T
 - a. Unit: DEARNG Counterdrug Task Force
 - b. Duty Location: AASF, 33 Corporate Circle, New Castle, DE 19720

 - d. Tour Dates: 01 March 2026 to 30 September 2026
 - e. Length of Tour: Estimated 214 days **(Contingent upon funding)**
 - f. Field Conditions: No
 - g. Per Diem: No
 - h. Billeting: No
 - i. BAH: Yes
 - j. Rations: No
 - k. Travel: Command to pay travel, as required
 - l. Dependent Travel Authorization: No
 - m. Rental Car Authorized: No
 - n. COLA: Based on Soldier's PDS for duty over 181 days. (FMR Volume 7a, Chapter 67).

3. Duties and Responsibilities: The Delaware National Guard Counterdrug Program is seeking to fill one position with a highly qualified individual. This individual will serve as a Non-Rated Crew Member and UH-72 maintainer with the DENG Counterdrug Task Force Aviation Section. Responsibilities include but are not limited to:

- a. Perform non-rated crew member duties over all types of terrain and urban environments, night, and day.
- b. Execute missions involving Counterdrug, Law Enforcement, transportation, routine, and emergency missions such as patrol, search and rescue, reconnaissance, disaster mitigation, and administrative flights.
- c. Operate Mission Equipment Package (MEP) under direction of Law Enforcement Officers/Agents.
- d. Support Law Enforcement Officers and Agents while maintaining intelligence oversight and operational security.
- e. Perform daily routine maintenance duties to ensure that aircraft remains mission capable.
- f. Prepare and display aircraft in support of educational training missions.
- g. Maintain written and computerized flight logs and aircraft and crew member records to comply with Army Regulations and other federal guidelines.
- h. Read periodic publications, directives, bulletins, etc. from the FAA and manufacturers; make necessary adjustments to helicopter operation based on information and directives.
- i. Coordinate with AASF personnel for scheduled and unscheduled maintenance requirements.
- j. Be able to work unsupervised, within DENG and Counterdrug guidelines.
- k. Perform safely in all tasks and display an image that reflects positively on the DE National Guard and the Counterdrug Task Force.

4. Qualifications and Requirements:

- a. Must be a current and qualified Non-Rated Crew Member in the MOS of 15T and possess the B3 identifier or have the ability to obtain the B3 identifier.
- b. FAA Airframe and Powerplant license preferred or possess minimum qualifications to obtain licenses.
- c. Law enforcement experience recommended. Previous experience in working with other government agencies, joint service operations, or other public safety sector agencies are an acceptable substitute for law enforcement experience.

- d. Completion of Counterdrug Doctrinal Training required pending hire.
- e. Strong Computer and technology skills.
- f. Excellent written and oral communication skills.
- g. Must possess a military driver's license and current civilian driver's license.
- h. Security Clearance: Secret and NACLIC required.
- i. Must demonstrate enthusiasm for new learning situations.
- j. Must maintain professional and military bearing and display a positive attitude.
- k. Personnel must receive a written recommendation from their unit commander.
- l. Must be able to work a flexible schedule to include weekends, overnight missions and extensive travel.
- m. Criminal records check and/or security screening must be completed by all selected for hire before coming on Counterdrug orders.
- n. Passing score required on most recent diagnostic or record AFT, height and weight within standards of AR 600-9.
- o. ARNG Soldiers must meet medical retention standards set forth in AR 40-501 Chapter 3 and Chapter 10.
- p. Urinalysis testing is required upon entry into active duty, and personnel are subject to periodic testing while on active duty. These requirements are in addition to testing by units of assignment during IDT/AT under ARNG Substance Abuse Programs.
- q. Requirement to continue attendance at IDT/AT while on FTNGD-CD orders.
- r. Standard of conduct: Soldiers participating in the Counterdrug Program are required to comply with state laws and with DoD Directive 5500.07. They are required to uphold the highest standards of conduct and personal appearance.
- s. Outside employment, associates, and off-duty conduct/ activities must be consistent with federal directives on ethics and with state and federal conflict of interest policies. Outside employment will require written approval of CDC according to CNGBM 3100.01 (dtd 30 July 2021).


