3. Soldier Qualifications:

a. Experience Preferred: Previous experience with Line of Duty (LOD) processing and medical readiness standards is desired but not required.

b. Must be a self-starter with working knowledge of Microsoft Office products.

c. Skill/qualifications: Good verbal and written communication skills as well as general administrative skills; must have HIPAA certification or the ability to obtain HIPAA certification.

d. Minimum Military and Civilian Education Required: MOS/Branch immaterial

e. Must have the eligibility to obtain a Secret clearance

f. Passing score required on most recent AFT/ACFT and must meet height and weight standards IAW AR 600-9 dated within 6 months from the closeout date on the announcement.
