- (6) Must complete, and provide, a favorable Behavioral Health Interview (DA Form 3822).
- b. <u>NGB Level Required checks (POC ARNG-GSS/HRP):</u> Must have favorable results showing no Type I or Type II offenses as listed in Annex A, HQDA EXORD 193-14. Additional screening will be accomplished by ARNG-GSS/HRP through:
 - (1) Department of Army Inspector General (DAIG)
 - (2) Criminal Investigation Division (CID)
 - (3) Office of Military Personnel File including Restricted Fiche Review (OMPF)
 - (4) Army Substance Abuse Program (ASAP)

 - f. Conduct prospecting IAW NGR 601-1 to support lead generation
